

List of Mandatory Posters and Helpful Telephone Numbers

Employers are required to display a number of posters in the workplace, in a location where employees can readily see them. These posters are required by different state and federal agencies and all are available for free from the agency that requires them. Many may be downloaded from the agency website.

Some posting requirements depend on the number of employees the employer has. Others depend on the type of business the employer is engaged in.
