1. MCAD ACADEMIC SPRING 2020 SEMESTER PLAN (attached)

This new document updates policy and process changes for the Spring 2020 semester. Due to the volume of decisions being made in short order, this document will be updated on a regular basis. In many cases we are maintaining policy, but providing new processes. If you have questions, please contact your department chair.
